- A. FMBFD/Iona McGregor Merger Study Presentation by J Angle Group LLC  
[Presentation/ Discussion/Action]

Jim Angle with J Angle Group provided a summary presentation of the feasibility study they performed. A copy of the study and the presentation can be found online.

Commissioners asked various questions throughout the presentation. The Board and Chief Wirth thanked J Angle Group for their hard work.

Commissioner Bennett suggested Board members go over the study until the next meeting in January and take next steps at that time. Chief Wirth requested a survey of the community over the next month now that the study is available.

  - A. Purchase of Two (2) Ford F150 Pickup Trucks [Information/Discussion/Approval]  
Chief Wirth presented information for the purchase of two (2) Ford F150 pickup trucks with upfitting to be used by the Life Safety staff totaling \$105,440.72. Commissioner Farrell motioned to approve the purchase of two (2) Ford F150 pickup trucks with upfitting totaling \$105,440.72 and authorizing an additional 5% allowance for unforeseen expenses, Commissioner Bennett seconded the motion. There was no discussion and the motion carried 5-0.
  - B. Purchase of One (1) Skydio Drone Docking Station [Information/Discussion/Approval]  
Chief Wirth presented information for the purchase of one (1) Skydio drone docking station, to be located at the new Station 31, totaling \$86,334.46. Commissioner Fleming motioned to approve the purchase of one (1) Skydio drone docking station, totaling \$86,334.46. Commissioner Knickle seconded the motion. There was no discussion and the motion carried 5-0.
